The NPN Creation Fund is Phase I of a three-part commissioning program that invests in the creation and development of new artistic work, advances racial and cultural justice, and centers exchange between artists and communities.

## Vision & Purpose

The Creation Fund supports artists creating a new work in its earliest stages, fostering relationships between artists, presenters, and communities. It provides a minimum of \$15,000 in unrestricted funding to support the *process and labor that goes into creating a new artistic work*. Projects are eligible to receive multi-level support through co-commissioners and direct NPN subsidies. The Creation Fund:

- **Fosters Equity:** Promotes racial and cultural justice within the arts.
- **Supports Artist Development:** Provides comprehensive support for the entire creative process.
- **Expands Access:** Increases access to commissioning opportunities, ensures equitable funding distribution, and addresses geographic disparities.
- **Cultivates Meaningful Partnerships:** Encourages long-term relationships and fosters new, authentic collaborations between artists, communities, and commissioners.
- **Strengthens Organizations:** Builds the capacity of organizations to develop artistic work.
- **Maximizes Impact:** Leverages additional funding, presentation opportunities, and national recognition to amplify the impact of supported projects.

# Part 2: Guidelines

## How funds can be used

Funds are unrestricted and can be used for a variety of needs, such as: artist, company member, and collaborator fees, basic life needs such as housing and food, research and development, materials, technical support, and/or anything else an artist may need to create a work.

Funds cannot be used to present the work once it is complete. Presentation fees are the responsibility of the co-commissioners.

## Who can access the Creation Fund?

[NPN National Partners](#) collaborate with an artist or artist company and at least one other commissioner to apply for a Creation Fund grant.

### Artist Eligibility:

- Artists/companies based in the United States and its territories, or Mexico.
- Artists/companies are ineligible if they have received a Creation Fund after May 1, 2023 and/or have another Creation Fund project in progress.

### Commissioner Eligibility:

- NPN National Partners may only participate as the Lead Commissioner on one project per Creation Fund round, however they can participate as a Co-commissioner on any number of projects.
- Although projects need to be led by an NPN National Partner serving as Lead Commissioner, other co-commissioners can come from outside of the Network.
- Co-commissioners can be any type of presenting or exhibiting organization, such as a theater, arts center, museum, gallery, community organization, producing artist company, university department, etc.
- Co-commissioners cannot be individuals.
- There is no limit to the number of Co-commissioners - projects may have an unlimited number of additional Co-commissioners.
- If the artist is a company member or staff member of one of the Co-commissioning organizations, a minimum of three co-commissioners (instead of two) must be identified.

# Phase I—Creation Fund Project Requirements

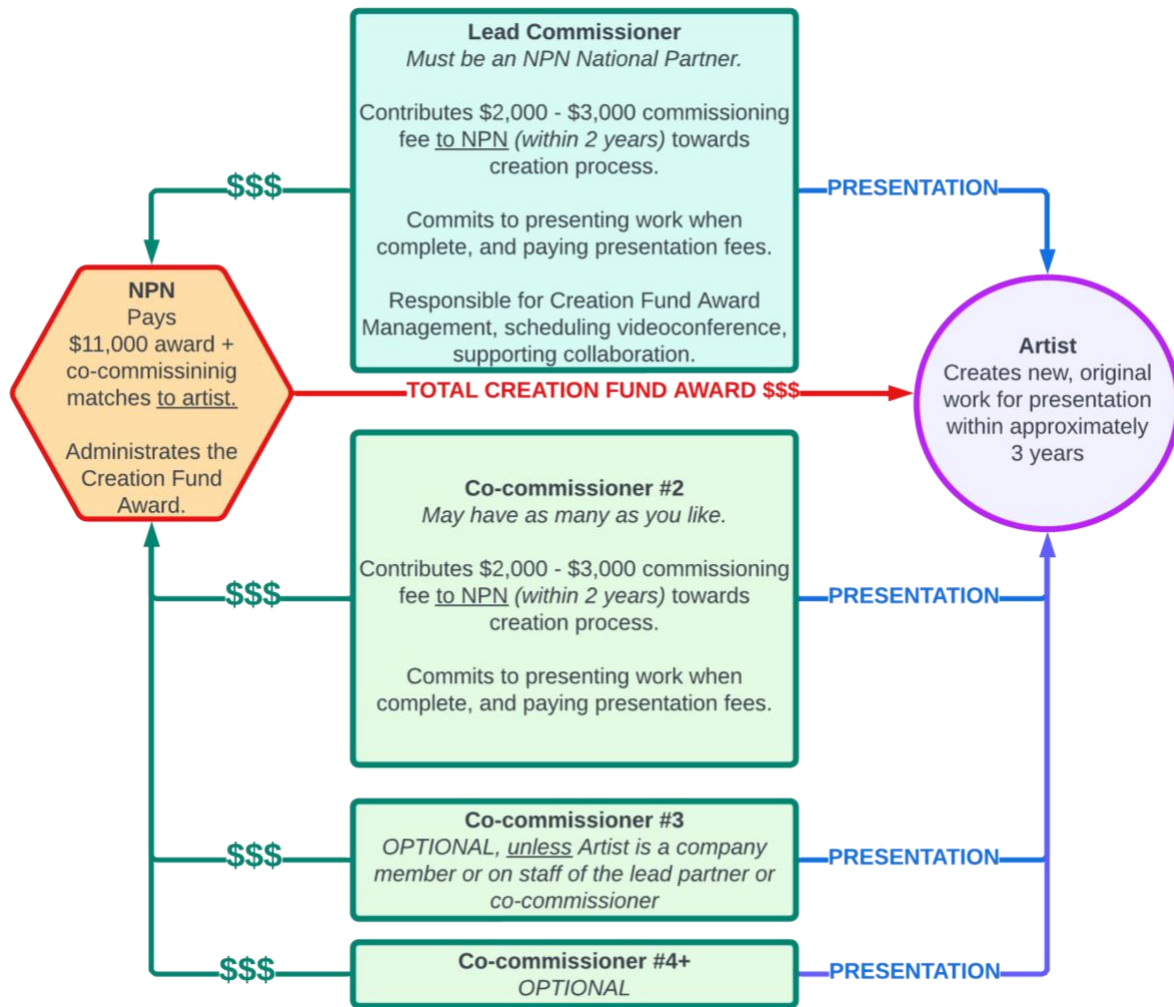
- Artistic projects must be in the early stages of creation, to be premiered between January 1, 2027 and December 31, 2029. We recognize timelines may shift.
- Projects must authentically advance racial and/or cultural justice. See Page 8 [Advancing Racial and Cultural Justice](#).
- Projects must culminate in an in-person, virtual, or hybrid exchange between the Creation Fund artist and each co-commissioner's community.
- In alignment with fostering an arts sector rooted in justice, NPN is committed to ensuring spaces, structures, and processes free of racism, transphobia, homophobia, ableism, misogyny, classism, or other bias. Our expectation is that all artists and co-commissioners receiving NPN support will honor this ethic.
- Artists and co-commissioners must credit NPN and co-commissioners for the life of the work in all marketing and promotional materials. Official Creation Fund credit language will be provided if awarded.

**Note:** There is no distance restriction between Co-Commissioners. Creation Fund proposals may focus on mobility, with Co-commissioners in different communities OR Creation Fund proposals may cluster Co-commissioners in one community for works that desire deep community involvement, or a project that takes place in multiple stages in one community.

## Commissioner Requirements

- One [NPN National Partner](#) must serve as the Lead Commissioner on each Creation Fund project. NPN National Partners may only participate as the Lead Commissioner on one project per Creation Fund round, however they can participate as a Co-commissioner on any number of projects.
- A minimum of two Commissioners (one Lead Commissioner + one Co-commissioner) must be confirmed at the time of application.
- Each co-commissioner must have the capacity to meet the co-commissioner requirements:
  - Pay a co-commissioning fee of \$2,000–\$3,000 **to NPN** by June 1, 2028
  - Present the work, through a paid public engagement, within three years. Artist fees for this presentation are the full responsibility of the Co-commissioner and should be paid to the artist in addition to co-commissioning fees.

## Lead Commissioner

The role of the Lead Commissioner is important, helping with the administration of the grant process. The Lead Commissioner:

- Begins the Creation Fund application and invites the artist to collaborate on the application.
- Invites the other Co-commissioners to fill out the Co-commissioner Details Form on the application.

If the project is awarded a Creation Fund, the Lead Commissioner:

- Serves as a liaison to the various parties participating in the Creation Fund (artists, co-commissioners, and NPN), as needed.
- Schedules the initial Creation Fund orientation.

- Helps to facilitate the Letter of Agreement signature process.
- Encourages the artist and Co-commissioners to check-in regularly about the development of the project.

## Co-Commissioning Fee

Each Co-commissioner commits to contribute a \$2,000–\$3,000 cash match depending on its organizational budget:

### Commissioning fees paid per organization:

Co-commissioning organizations	Amount
With annual organizational budgets of less than \$1 million	\$2,000 each
With annual organizational budgets greater than \$1 million	\$3,000 each

- Matches cannot be in-kind, and must be paid directly to NPN **no later than June 1, 2028**. If a co-commissioner cannot pay the cash match by June 1, 2028, then the project should apply in a future cycle.
- **NPN matches these funds with \$11,000** so that every Creation Fund project receives a minimum of \$15,000 of funding:

### Minimum Award Example:

Source	Amount
NPN Award (\$11K)	\$11,000
Lead Commissioner (\$2K-\$3K)	+\$2,000
Co-Commissioner (\$2K-\$3K)*	+\$2,000
<b>Minimum Total Creation Fund Award</b>	<b>= \$15,000</b>

\*Additional Co-Commissioners are encouraged but not required.

## Public Engagement

Co-commissioners commit to a paid public engagement of the commissioned Creation Fund project within a three-year period of the award date. This exchange can take any format, such as a public presentation, performance, exhibition, a series of workshops,

and/or community residency, as long as it centers a live experiential artistic exchange between the community, the artist, and the new work. Public engagement may take multiple shapes and forms, whether it be an in-person, virtual, or hybrid engagement.

- Artist fees for these exchanges are the full responsibility of the Co-commissioner and should be paid to the artist in addition to commissioning fees.
- Co-commissioners who are NPN Partners may opt to use their annual allotment of Artist Engagement Funds to support artist fees for these exchanges. (optional)

## Advancing Racial and Cultural Justice

NPN recognizes there are many strategies to advancing racial and cultural justice and will support a variety of approaches that benefit artists, organizations, and communities impacted by current and historic systems of oppression – if they are explicit, transparent, and authentic. Furthering this goal may look like:

- Commissioning an artist of color, an Indigenous/Native/First Nations artist, an artist with disabilities, or a trans artist
- Supporting a project that deals with issues of racial or cultural justice
- Supporting a process that builds work with communities that are, or have been underinvested in, etc.

Before applying, please carefully consider how projects fit these goals. If applying for a work that advances cultural – as opposed to racial – justice, the applicant must articulate the involvement of, and impact on, communities of color.

Not every new work project fits the goals of the NPN Creation Fund. If the Lead Artist **does not** identify as a person of color, Indigenous/Native/First Nations artist, an artist with a disability, or a trans artist, please consider the following before applying:

- How will this project advance racial and/or cultural justice?
- Why is racial and/or cultural justice important to you (the artist)?
- What is your (the artist's) history of working to advance racial and/or cultural justice and how do you currently work with your community to advance racial and/or cultural justice?
- Are the collaborators being paid fees by this project representative of the community you are engaging/serving?
- How are artistic, financial, and administrative decisions for this project made and who makes these decisions?
- What learning or unlearning are you doing as you work to dismantle white supremacy?

## **Project Scale & Scope**

All parties to the Creation Fund project (artist, lead commissioner, and co-commissioners) should articulate their understanding and agreement of the proposed project's scale, scope, and cost in the application. While it is difficult to anticipate the results of an unrealized creative project, an effort should be made to set realistic expectations within certain parameters and budgets. Honest and explicit planning is highly recommended and encouraged.

In light of NPN's recommended fee structure and its emphasis on thriving wages, special care should be taken to consider the ideal size of the project's company members, including artists, company leadership, and technical personnel. There is no universal "ideal" company size, but factors such as artist fees, travel, lodging, and per diem can have a significant impact on a touring work's viability. The same is true for the freight cost of large set pieces, and equipment necessary for the production. When possible, it might be advantageous to plan for a larger "homebase" production for exhibitions or presentations close to home, and a nimbler version for touring.

## **Additional NPN Support for Creation Fund Artists**

### **Phase II—Development Fund**

Additional Development Funds are earmarked for every Creation Fund Project. NPN invites artists who have received Creation Fund support to apply for development support through the Development Fund. These funds can support a variety of needs when developing a work for public engagement. Guidelines are flexible in design to meet the unique needs of each project. The Development Fund is available throughout the year on a rolling deadline. Artists can apply once during the three years following their Creation Fund award. Development Funds are artist-driven. Artists may apply for:

- up to \$10,000 for team-based projects with a co-commissioner of their choosing, or
- up to \$5,000 if not working with a co-commissioner.

### **Phase III—Public Engagement**

Once a work is developed, co-commissioners support artists through a public engagement of the new work, focused on an in-person, virtual, or hybrid exchange between artists and communities. NPN remains flexible with the definition of public engagement. NPN Partners should consult Artist Engagement Fund guidelines for more details.

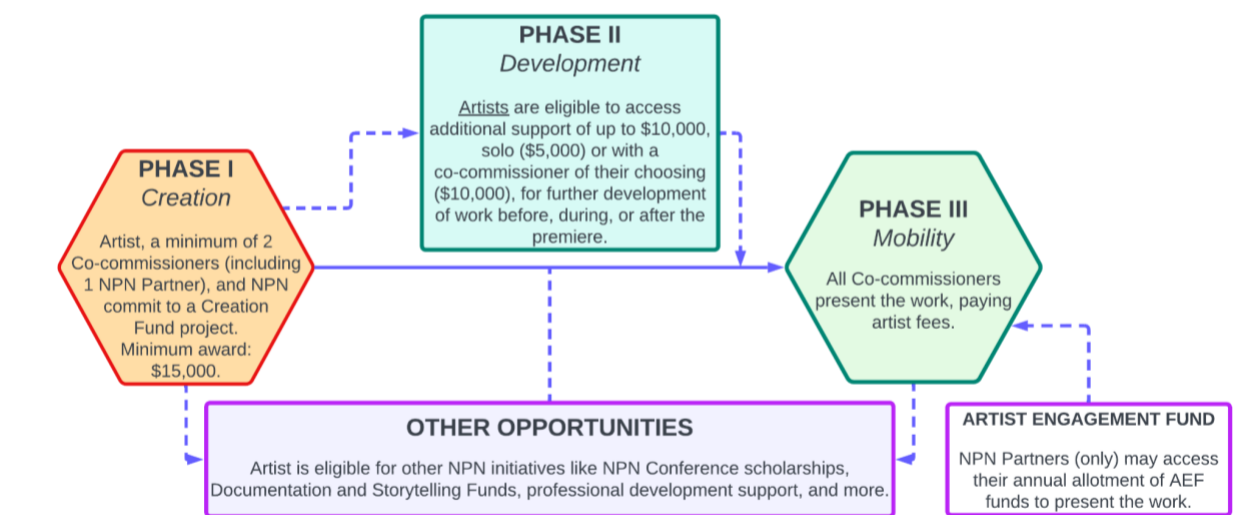
## NPN Conference Support

NPN offers attendance subsidies for a limited number of Creation Fund artists at its NPN Conference, which is a forum to experience creative work, explore alternative models in arts presenting, learn about local communities, and address the most critical issues in our field.

## Other Types of Support

On occasion, NPN has discretionary funds set aside for NPN-supported artists through [specific initiatives](#), such as the Documentation & Storytelling Fund.

## Application Tips

- NPN understands that projects, timelines, and work may shift. Please use your best judgment when completing the application. If awarded, NPN will commit to the project, regardless of whether the project and/or timeline shifts.
- Keep it clear and simple! We don't judge applications on grantsmanship, so use plain language, and don't feel the need to fill up all the narrative spaces. Applicants can submit applications with written, video, or audio narratives.
- Be sure to give yourself enough time to secure the commitment of co-commissioners, collect information, and build the project timeline and budget.
- When completing the application, make sure to focus the request—narrative, timeline, and budget—on the *Creation Phase* of the project.

- Review [Part 3: Application Guide](#) in this document prior to completing the online application.
- Applicants can upload a project budget and timeline of their own, or use the template provided.
- IMPORTANT! Once you submit your application you will receive an email receipt of acceptance. If you do not receive this email, your application has not been submitted.

## Selection Process

Because NPN conducts its work through the framework of the NPN Network, we receive a limited number of applications. Most of the time we can fund all applications, as long as they fit the program criteria. If NPN receives more applications than it can fund, NPN will convene a peer panel of artists and cultural workers to select awards. Please note awards will not be made based on the language, grammar, or writing. Additionally, projects will not be judged on artistic merit or career successes, but rather their alignment with NPN's program goals and quality of relationships. NPN will fund 18 - 23 projects in this application round, prioritizing projects using the following criteria:

- Artists and co-commissioners who represent communities that are and have been historically underinvested in, including but not limited to communities of color, Indigenous/Native/First Nations, disabled, trans, and rural communities.
- Projects that advance racial and/or cultural justice.
- Projects that honor authentic relationship building.
- Projects that are in the early, creation phase of development, as opposed to near completion.

## Honoraria

NPN tries to fund a majority of submitted applications (if they fit the criteria). In the case that NPN is unable to do so, we provide a \$250 honorarium to artists who are not selected, to honor the time spent on the application.

## Section 1: Lead Commissioner Instructions

The NPN Partner who is serving as the Lead Commissioner **must begin the application.**

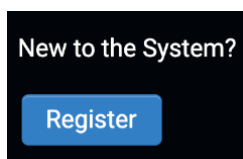
Once the draft application has been created, the Lead Commissioner will invite the Artist and other Co-commissioners to participate in the application. As such, the instructions for each role (Lead Commissioner, Artist, and Co-commissioner(s)) are divided into three parts, beginning with the Lead Commissioner.

### Lead Commissioner: Setting up an Account

If you already have an account in our system, go to <https://npnetwork.smartsimple.com> in your web browser to login.

### Lead Commissioner: Starting a Creation Fund Application

### Lead Commissioner: Invite the Artist

Once the application opens, save your draft using the “Save Draft” button at the bottom of the screen. This enables full functionality of the application.

Once you have saved your draft, click on the blue “Invite Artist” button.

Add the artist’s name, email and role, then click “Invite” to add the artist to the application.

It may take up to 5 minutes for the artist to receive an invitation email. If for some reason the artist doesn’t receive the invitation, they may want to check their email spam folder. Once the artist has accepted the invitation to participate, they will be granted access to create an account in the system and collaborate with you on the application.

### Lead Commissioner: Invite the Co-Commissioner(s)

Navigate to the “Co-Commissioner Information” tab in the application.

First, click on the blue plus button to fill out a “Co-Commissioner Details” form as the Lead Commissioner.

Then, use the “Invite Co-Commissioner(s)” button to send an email invitation to the co-commissioner(s).

Add the Co-Commissioner’s name, email, and role by selecting the blue “plus” button. For Role, select “Co-Commissioner CreFund.” Repeat this for each additional Co-Commissioner.

It may take up to 5 minutes for the Co-Commissioner to receive an invitation email. Once the Co-Commissioner has accepted the invitation to participate, they will create an account in the system and fill out and submit a “Co-Commissioner Details” form.
